Promotion Benefits	<p>Eligible Customers will receive 50% discount off monthly plan fees for the first 6 months on an Eligible Plan.</p> <p>This is in addition to the AGL Monthly Credit of \$5 for AGL Energy Residential customers.</p> <p>As an example, for the Medium plan, Eligible Customers will pay \$15 per month in plan fees for the first 6 months:</p> <p style="padding-left: 40px;">\$35 per month (full price) minus AGL Monthly Credit of \$5 minus 50% promotional discount = \$15 per month</p>

For port-in numbers, you must activate your AGL mobile SIM after the SIM card is delivered to you (by following the prompts to activate your service), and within thirty (30) calendar days of purchase. Failure to do so will result in your AGL mobile SIM plan service being cancelled and the SIM card will no longer be valid.
