AGL Battery Rewards Prepaid Digital Visa Card offer Terms and Conditions

Last updated: 14 August 2025 Offer and Eligibility

- 1. AGL (also referred to as 'us', 'our' or 'we') offers an AGL Prepaid Digital Visa Card to eligible residential customers (referred to as 'you' or 'your') who sign up to AGL's Battery Rewards Plan ('Energy Plan') for a supply address in VIC, NSW, QLD or SA (the 'Offer').
- 2. If you export electricity to the grid between 5pm and 9pm on any day of the week ('peak window'), you could receive a Prepaid Digital Visa gift card ('gift card') via email each billing quarter. Your billing quarter starts on the date you join the Energy Plan. The value of any gift card depends on how much electricity (in kilowatt hours, kWh) you export to the grid in the peak window during your billing quarter. You'll receive a \$10 gift card if you export between 1kWh and 40kWh, and for every additional 40kWh an extra \$10 will be added to the gift card value up to a maximum of \$400 each quarter.
- 3. The gift card will be sent via email with an activation email and instructions on how to redeem your Digital Gift Card. Follow the prompts in the email to confirm your preferred mobile number online. Next, you'll receive an SMS with a link and instructions on how to access your Digital Gift Card. Follow the prompts in the SMS to add your Digital Gift Card to your digital wallet. You must activate your Digital Gift Card prior to use, and your Digital Gift Card will be valid for 36 months from the date of issue.
- 4. The AGL Prepaid Digital Visa Card offer is separate to your AGL energy plan and Market Retail Contract. The AGL Prepaid Digital Visa Card offer is governed by these AGL Prepaid Digital Visa Card Terms and Conditions ('Terms and Conditions') and any specific terms and conditions provided as part of the Offer.
- 5. Customers will not be eligible to receive their AGL Prepaid Digital Visa Card if they exercise their cooling off rights or otherwise cancel the relevant AGL Energy Plan prior to the end of any minimum period specified in the Offer (including if they swap to an alternative AGL Energy Plan), or where they do not meet specific eligibility requirements communicated as part of the Offer.
- 6. Each Offer has a limit of one AGL Prepaid Digital Visa Card per supply address.
- 7. Each Offer has a limit of one AGL Prepaid Digital Visa Card per quarter.
- 8. AGL may exclude customers who have received an AGL Prepaid Digital Visa Card for a supply address in the previous 12 months from receiving an additional AGL Prepaid Digital Visa Card.
- 9. To be eligible to receive your AGL Prepaid Digital Visa Card, you must provide a valid email address and Australian mobile number and follow the activation process outlined above or as notified to you by AGL.

AGL Prepaid Digital Visa Card

- 10. Your AGL Prepaid Digital Visa Card can only be used on your smart phone device. It cannot be substituted for a physical card, transferred, reloaded or redeemed for cash, and it cannot be used to purchase other gift cards.
- 11. Your AGL Prepaid Digital Visa Card can be used anywhere Prepaid Visa Gift Cards are accepted online and in-store with contactless point of sale terminals. Your AGL Prepaid Digital Visa Card cannot be used as a credit card or linked to any deposit account.

- 12. To redeem your AGL Prepaid Digital Visa Card, you will first need to register your details with the gift card provider. Any ancillary costs, such as booking fees associated with using or redeeming your AGL Prepaid Digital Visa Card are not included. For the avoidance of doubt, there are no post-supply fees prohibited by the Australian Consumer Law associated with redeeming your AGL Prepaid Digital Visa Card.
- 13. Your AGL Prepaid Digital Visa Card is valid for 36 months from the date of issue. Your 16 digit Prepaid Digital Visa Card number, expiry date and CVV will be displayed on screen and can be added to your digital wallet on your smartphone device. Your card balance and expiry date are also available free of charge at www.myprepaidcentre.com.au or by calling 1800 778 619. At the expiry of the Prepaid Digital Visa Card any unused balance will be forfeited. You will not receive notice prior to expiry.
- 14. Your AGL Prepaid Digital Visa Card is issued by Heritage and People's Choice Limited trading as Heritage Bank ABN 11 087 651 125 ('Heritage') pursuant to a licence from Visa Worldwide PTE Ltd. Blackhawk Network Australia Pty Ltd ACN 123 251 703 ('Blackhawk') is Heritage's program manager for the Prepaid Digital Visa Card.

- 17. Except to the extent otherwise required by law, AGL will not be liable to you for any loss, damage, cost or expense incurred as a result of or in connection with your email address or phone number being incomplete or inaccurate.
- 18. If for any reason any aspect of this Offer is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of AGL, AGL may in its sole discretion cancel, terminate, modify or suspend the Offer.
- 19. By participating in this Offer, you understand and consent to AGL collecting and using your personal information, and disclosing your personal information to our related entities, agencies, promotion partners (including our Visa Card issuer) and other third parties where engaged in connection with this Offer, for the purpose of providing you with this Offer and in accordance with our privacy policy available at agl.com.au/privacy-policy.
- 20. AGL reserves the right to cancel any Prepaid Digital Visa Card issued if it reasonably suspects that they have been obtained or used fraudulently or illegally, or in breach of the Terms and Conditions of this Offer.
- 21. AGL reserves the right to change the Terms and Conditions of this Offer, or withdraw the Offer at any time, but we'll let you know by posting revised Terms and Conditions on AGL's website. AGL will honour any existing Offer that is current at the time of any such variation.
