## Field operations.

- > No CSG Drilling since September 2012.
- > Well workovers undertaken in the EMAI, Menangle Park and Sugarloaf fields.
- > 4 well plug and abandonments in progress in the EMAI and Stage 1 fields.
- > Minor flooding in the Menangle Park field on 22 April. Air bubbling observed along river bank as water levels increased. EPA Officer inspected site with gas detector and confirmed that the air bubbling was not methane.

- > Compressor 1 Engine restart
  - » Delayed until further notice due to mechanical issues.
  
- > Noise monitoring

- > Air emissions monitoring
  - » April and May monthly monitoring results compliant.
