Field Operations.

Production wells

12 volt air compressors installed on all operational wells to reduce fugitive emissions from instrumentation. Leak detection and repair surveys to be completed in November 2016.

Well workovers

Completed in Spring Farm and Menangle Park during April.

Workover rig presently working in Gloucester and scheduled to return to Camden in November.

Well site rehabilitation

Early planning for final project rehabilitation.

One well (LB05) P&A completed and a further four P&A's near completion.

A further 6 wells to be P&A'd in FY17.

Good rehabilitation progress on recent P&A'd wells.

Noise Monitoring

June 2016 quarterly results compliant.

Air Emissions Monitoring

All monthly and quarterly results compliant.

Compressor 1 Restart Project

5 week start up period from 25 May to 28 June 2016.

All works complied with EPL 12003 Condition E1.

Total NOx load from RPGP was 2,008kg, significantly below the 6,600kg load limit for the 5 week period.

June Floods

Approximately 7,632L of produced water was released from three tanks during the flood.

The EPA has considered the impact of this volume of produced water on the flood water that was present in the catchment at the time and considers the environmental impact to be low.

AGL is working with the EPA to review AGL's flood management procedures in line with the EPA's lead regulatory role under the NSW Gas Plan.
