3.30.01	Civil works are now 'complete'. Whilst this is the case, road maintenance is conducted as required.	Note
3.30.02	Site delivery of all major components is now complete. This is a great milestone for the team	Note
3.30.03	AGL is continuing to work closely with both AEMO and the NSP (TransGrid) in relation to the commissioning of the wind farm. We currently have 13 wind turbines operating during the day-time and recently received approval to increase night-time generation to 18 wind turbines (62MW).	Note
3.30.04	AGL will complete a step test at 18 wind turbines (62MW) before seeking approval to proceed to 22 wind turbines (67MW).	Note
3.30.05	GE-CATCON is continuing to progress rehabilitation of the disturbed areas on site and finalise implementation of erosion controls (placement of rocks in drainage channels).
