Currently working through updates to the BBAMP, once complete this will allow the review for the Year 2 Monitoring report to re-commence. Successful meeting with BCD to ensure the required updates are being implemented in the plan. Biodiversity	<p>Ongoing actions conducted as per the Operational Biodiversity Adaptive Management Plan, Bird and Bat Adaptive Management Plan, Porcupine Grass Sparse Woodland Recovery Plan, Barrier Range Dragon Management Plan, Goat Management Plan, Vegetation Management Plan. No recorded impacts to: Porcupine Grass Sparse Woodland; Mulga/Red Mallee Shrubland; Barrier Range Dragon habitat.</p> <p>Barrier Range Dragon monitoring has been re-evaluated to five-yearly increments as per approval from the NSW DPE.</p> <p>The Vegetation Monitoring Report Year 2 - report has been submitted to the BCD and the DPE for review.
